

ORDINANCE NO. 2195-09

AN ORDINANCE REPEALING AND RECREATING CERTAIN
SECTIONS OF CHAPTER 15 OF THE MUNICIPAL CODE,
COMMONLY KNOWN AS THE ELECTRICAL CODE

The Common Council of the City of Brookfield does ordain as follows:

PART I. Section 15.08.240 of the Municipal Code, Chapter 15, relating to the Electrical fee schedule is hereby repealed and recreated to read as follows:

11.	Motors over ¼ HP - .50 per HP or fraction	Min. \$8.00 each

13.	Transformers, rectifiers, generators and capacitors max. \$500 (per KW/KVAR)	\$2.00
14.	Electrical heating systems .50 per KW	Min. \$8.00
15.	Post light, power receptacles/230 volts or over & power poles	\$9.00 each
16.	Busways, wireways, underfloor raceways or auxiliary gutters	(per ft) - \$1.00
17.	Strip lighting, plug-in strip, Trol-E duck or similar system	(per ft) - \$.80
18.	Arc, mercury, HID lights, dimmers, photocells, timer clocks	\$4.50 each
19.	X-ray machines, motion picture machines, CAT Scan, MRI etc.	\$50.00 each
20.	Dimmers & Motion Detectors	\$4.00 each

21.	Signs .50/socket plus 2.50 each addnl. transformer	Min. \$65.00
22.	In ground/above ground swimming pool or hut tub	\$60.00
23.	Hydro-massage whirlpool (bathtub)	\$45.00
24.	Signal or communication device (audible or visible)	\$1.00 each
25.	Reinspection or failure to call for final inspection	\$60.00
26.	Double permit fee if permit is taken out after installation is started	
27.	Electrical License Fee	New \$65.00 Renewal \$55.00

MINIMUM CHARGE FOR ANY ONE PERMIT \$65.00

A minimum refund fee of \$75.00 will be charged for all requested refunds for permit fees which have already been processed.

PART II. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

PART III. This ordinance shall take effect and be in force from and after its passage and publication.
