**Abutting Property Owners Permission:** Abutting property is any property touching the prospective beekeeper’s property, including those that touch at only a corner, but required only from single-family homeowners. Permission granted here may be withdrawn by a property owner by filing a written statement with the City of Brookfield Inspection Services Department, pursuant to §15.04.350 of City Code. Only one property owner signature is required for either permission or permission withdrawal per parcel regardless of the number of persons who may own the property.

A beekeeper has one year from the date a permit is issued to install any hives, otherwise the permit expires and the permit process must be started again, including permission from the neighbors.
