2021 City of Brookfield Personal Property Tax Information

Enclosed is the 2021 City of Brookfield Personal Property Tax Statement.

Personal property tax bills mailed in December of each year are based on the property assessment as of the previous January 1st, and are due and payable by the January 1st owner of record.

The Personal Property tax bill must be paid in full by January 31st, 2022.

Wisconsin State Statutes require all delinquent taxes are subject to interest and penalties of 1.5% per month going back to February 1st, 2022 until paid in full.
