I. Plan requirements

All plans shall be drawn to a scale of not less than one eighth (1/8) inch per foot, and *must* have property address on all copies. Drawings must be to scale and accurately figured. Drawings that do not show all necessary detail shall be rejected.

A minimum plan submittal must include:

- 1. A Wisconsin licensed architect or engineer's stamp on index page or on each sheet.
- 2. <u>State approved plans are required UNLESS:</u>
 - a. Project is an addition to an existing building containing no more than 2500 square feet, no more than one floor level, 18-foot maximum roof spans, and 12-foot maximum exterior wall height;
 - b. Project is an alteration to an existing building where the portion of space being altered is less than 100,000 cubic feet of total volume.
- 3. Floor plans, specialty plans, elevations, cross sections and details.
- 4. Structural calculations and specifications.
- 5. HVAC plans
- 6. Landscape Plans
- 7. Building, erosion control and occupancy permit applications
- 8. Lighting power budget calculations.
- 9. Handicap accessible route plan.

II. Data Requirements

- A. Three (3) copies of **STATE APPROVED** (if required) building plans including exterior elevations as approved by the Plan Commission.
- B. One (1) Copy of landscape plan, included in all three (3) plan sets. This plan must indicate all changes required by the City Plan Commission.
- C. Six Surveys
- D. Description and Value of Work Form

All site details, plans, materials, and specifications must meet the conditions recommended by the Plan Commission and approved by the Common Council. These are minimum requirements, certain conditions may require additional information.

Before a Certificate of Occupancy can be issued, you must fill out and return the "Description and Value of Work From". This form is available on the city's website; if not turned in at time of submission, it will be included with the building permit packet and must be filled out and returned.
