The Common Council of the City of Brookfield does ordain as follows:

PART I. Section 15.08.240 of the Municipal Code, Chapter 15, relating to the Electrical fee schedule, is hereby repealed and recreated to read as follows:


MINIMUM CHARGE FOR ANY ONE PERMIT \$73.00 \$76.00
