If the owner is a corporation, the following information must be included: the name of the corporation exactly as set forth in the Articles of Incorporation; date and state of incorporation; and the name and residence address of each of its officers, directors, and each stockholder holding five percent or more of the stock or beneficial ownership of the corporation. The Corporation must appoint an agent. The application must also be verified by an officer of the corporation. (Application signed and notarized by an officer of the Corporation.)

B. If the applicant is a partnership, the applicant must supply the name and residence address of each of the partners, including limited partners and be verified by each partner. (The application signed and notarized by each partner.) If one or more of the partners is a corporation, the provisions of this section pertaining to a corporate applicant shall apply to the corporate partner.

C. If the applicant is neither a corporation nor a partnership, the application shall set forth the true full name and residence address of the applicant and shall be verified by the applicant. The application shall also include any other name by which the applicant has been known during the previous five years: _____
